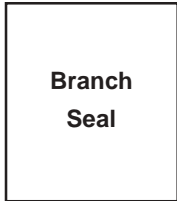

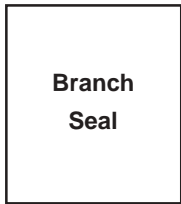

- ❖ **Public Limited Company**  
Certified copy of the Memorandum and Articles of Association, Certificate of Incorporation, Certificate of Commencement of Business, Rubber stamp of the Company, Resolution permitting the company to apply for requisite shares and authorizing directors to sign on behalf of the company.
- ❖ **HUF**  
HUF declaration alongwith signature of all major coparceners, rubber stamp of HUF.
- ❖ **Trust**  
Certified copy of the Trust deed, resolution passed by the trust authorizing the officials to sign on behalf of the trust, rubber stamp of the Trust/Managing Committee.
