

SVC-YOUTH

RULES AND REGULATIONS

1. Account shall be opened in the name of youth in the age group of 18 years to 25 years.
2. Account shall be opened with a minimum balance of Rs.1000/-, an Average Quarterly Balance of Rs.1000/- should be maintained.
3. Mode of holding: Singly/Jointly/Jointly with survivorship benefits. The first account holder has to be eligible as per the above eligibility criteria.
4. Demand draft / Bankers Cheque will be issued free.
5. The account holder shall have a free ATM card facility, Free Net Banking and SMS Banking , subject to the terms and conditions on ATM Cards, Net Banking SMS Banking as decided by the Bank from time to time.
6. All the KYC norms to be followed while opening the account. Account holder to submit proof of identity and proof of residence.
7. Rate of interest of SVC -YOUTH account shall be as applicable to normal savings account.
8. Penalties: Non-maintenance charge -Rs. 150/- per quarter. Closing the account before completion of 6 months: Rs. 100/-.
9. Nomination facility available.
10. The Bank reserves the right to alter, change, add, modify, delete, revise any terms and conditions at any time at its discretion. The facilities presently offered are as per the discretion of the Bank and are valid for 1 year. This may be subject to review after 1 year.
