

Group Activ Secure - Personal Accident Claims Process

- All insured will be covered for Accident Death benefit under this policy. All claims arising under this product / policy will be serviced directly through ABHI in house team.
- Insured / Nominees should ideally intimate the company within 7 days of occurrence of an event. Claim can be intimated to ABHI contact centre via Call or through an Email. Insured / Nominees can submit the claim documents along with duly filled & singed claim form at nearest ABHI Branch office or can directly send the documents at ABHI Head Office – Goregaon within 30 days of occurrence of an event.
- In case there is non-intimation of claim or delay in submission of claim documents, ABHI will consider claim if valid reason provided.
- All claims received at ABHI will be processed within 5 working days and claim decision will be shared with insured / Nominee. Additional claim document requirement (if any) will be conveyed to the insured / nominee through Email, SMS and Outbound Call through Care Manager.
- ABHI will settle all eligible claims to the insured / nominee within 7 working days. Settlement communication will be shared with Insured via Email / SMS / Out Bound Call through Care Manager.
- We also have regional language support to guide insured at the time of his claim for Hindi, Marathi, Telugu, Kannada, Malayalam, Tamil.
