## SVC Minor Account RULES AND REGULATIONS (To be signed by Guardian(s) only)

- 1. Account shall be in the name of Minors with Guardian(s) as Operator in the age group of 0 yrs. to below 18 yrs.
- 2. Account shall be operated by the Guardian(s) only.
- 3. Cheque book shall be issued in the name of the Minor
- 4. The account holder being Minor shall be allowed to maintain Rs: 500/- \*balance in the account. At the time of opening the account it has to be opened with a minimum balance of Rs. 100/-
- 5. ATM Card with a Daily ATM Cash Limit of Rs: 10,000/-\* & POS Limit of Rs: 15,000/-\*
- 6. All KYC norms to be followed while opening the account. Guardian(s) to submit proof of identity and proof of residence. Copy of Minors Passport/PAN card/Identity card should also be submitted.
- 7. Rate of interest on SVC Minor Account shall be as applicable to normal savings account.
- 8. On attaining majority, the Account Holder should submit the relevant documents along with the letter to continue operations in the account. The Account holder shall maintain the minimum balance as stipulated in the account.
- 9. Penalty of Rs: 200/-\* will be levied in case of account is closed within 1 year from the date of opening the account.

I/ we also understand and accept that in case I / We fail to maintain an Average Quarterly Balance of Rs.500\*/- in the account, the Bank shall charge Penalty of Rs.200\*/- per quarter, for non maintenance of required Average Quarterly Balance to the account
